Based at the Wetaskiwin Shop and reporting to the Utilities and Shop Foremen, the successful candidate will assist with the daily operation and maintenance of the Winfield and Wetaskiwin Shops and nine solid waste transfer stations. Work will involve maintenance and light repairs to site facilities, assisting with equipment maintenance in the field, and the operation of a skid steer and small dozer at the

Regular hours of work are ten (10) hours per day Monday to Friday commencing at 7:00 a.m. to 5:00 p.m. This Seasonal position will be for a term of seven (7) months, April 1 to October 31, 2019 inclusive.
