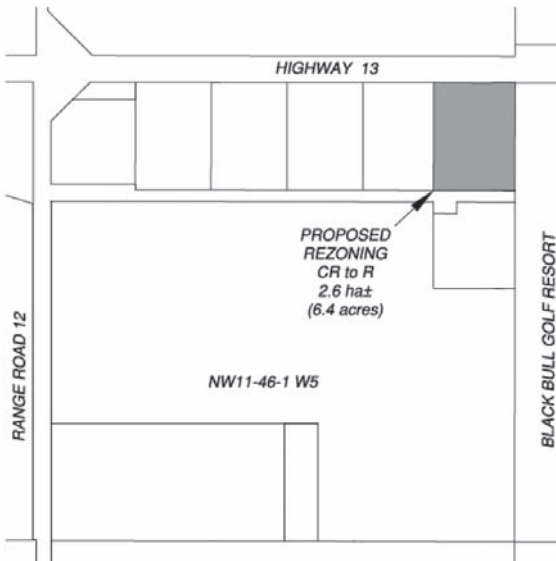

TAKE NOTICE that at the September 17, 2015 Council for Planning and Development meeting, it was approved by Council that Administration begin the process for the removal of Municipal Reserve designation within SW 28-47-24-W4M from the current Lot 20 MR to the new proposed reserve location (RR 244) and the proposed internal subdivision road.

The new Municipal Reserve cannot be designated until the removal of the 'old' Municipal Reserve. In accordance with Sections 674 and 675 of the Municipal Government Act (MGA) for the relocation of the Municipal Reserve Designation located within SW 28-47-24-W4M, public notice and a Public Hearing must be held.

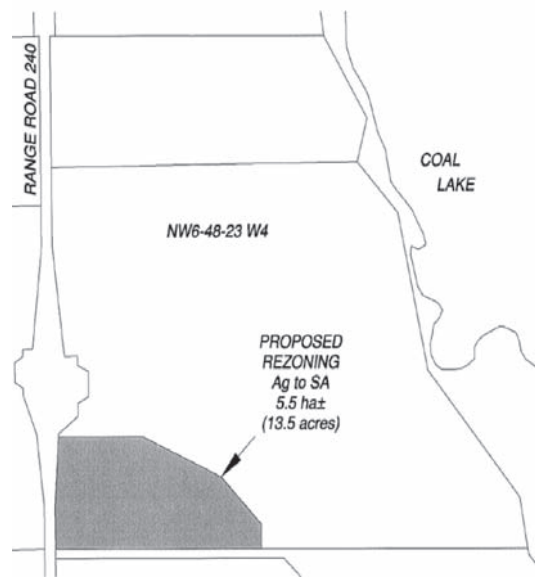
