The Position:

The County of Wetaskiwin is seeking a permanent full time Shop Hand based out of the Wetaskiwin Shop. Reporting to the Fleet Services Foreman, the successful candidate will be responsible for assisting the Automotive and Heavy-Duty Mechanics in their daily work along with general shop and yard work. Duties include the use and care of shop equipment and tools, welding and general metalwork, management of parts and inventory, parts delivery and pick-up, and pressure washing of fleet vehicles. Regular hours of work are 8:00 a.m. to 4:30 p.m., Monday to Friday.

Required Skills:

The successful candidate will possess:

- A Class 5 Driver's license; having air endorsement, Class 3 or Class 1 is preferred;
- Good physical condition as the work is physical in nature and on occasion, heavy lifting is required
 as part of regular duty;
- · Metalwork repairs; cutting, welding, grinding and assembly;
- A self-starter with the ability to work independently and without constant supervision;
- A team player, able to work in a fast-paced team environment and work well with other shop personnel.

Salary is in accordance with Appendix A - Wage Schedule of the International Union of Operating Engineers, Local Union No. 955 Collective and County of Wetaskiwin No. 10 Agreement, salary range of \$22.69 to \$25.21 per hour commensurate with experience. This position, if assigned to welding and metalwork repair work, will be paid a Welder Premium Rate of \$4.00 above the current salary range.

FIRE GUARDIANS - 2021

Fire Permits are <u>REQUIRED</u> from <u>March $1^{\underline{st}}$ to October $31^{\underline{st}}$ and may be obtained from the Fire Guardian in your area.</u>

An application for a Fire Permit should be made two or three days prior to the first day of burning. A Permit will be issued for a maximum ten-day period beginning from the date of issue; however certain conditions may be required in order for a permit to be issued. If an extended period is required for burning, application must be made for another Fire Permit after the first Permit is terminated.

PERMISSION TO BURN STUBBLE:

Under the Soil Conservation Act the County of Wetaskiwin has the authority to issue Stubble Burning Permits. These permits are issued on an individual basis and a site inspection must be performed. Contact the Director of Agricultural Services, Stephen Majek at 780.361.6226 to obtain a Stubble Burning Permit.

YOUR RESPONSIBILITY AS A HOLDER OF A FIRE PERMIT:

- 1. A Fire Permit gives authority to the permittee to set a fire according to the regulations and the terms and conditions printed on the Permit. Conditions stated on your fire permit must be strictly adhered to. You may be liable for fire suppression costs or penalties as provided by law for any damage that may occur while burning without a permit, or for failing to comply with the conditions as stated on your fire permit.
- A Fire Permit <u>DOES NOT</u> relieve the holder from the responsibility of keeping that fire under control and extinguishing, if necessary.
